

Investing through SEEDRS – Step-by-Step Guide

BEFORE YOU START THE PROCESS TO PURCHASE SHARES, IF YOU ARE NEW TO SEEDRS PLEASE MAKE SURE YOU HAVE YOUR NATIONAL INSURANCE NUMBER, DRIVING LICENCE AND A JPG OR PNG FILE OF YOUR PASSPORT OR DRIVING LICENCE AND A PDF, JPG OR PNG FILE OF A RECENT UTILITY BILL TO UPLOAD TO THE SEEDRS SITE, SO PLEASE SCAN THESE BEFORE STARTING.

1. If you have not used Seedrs before and do not have an account with them, click on the green “Sign Up” button. Complete the page, selecting a password with a minimum of 8 characters with at least 1 letter, 1 number and 1 symbol
2. Seedrs will send you an email. Go to your email and click on the link (“Confirm” button) within the confirmation email (this takes you back to the Seedrs site). Answer the questions and Accept the terms at the end.
3. Answer the questions on the Quiz. This is a requirement of the Financial Services industry. Don’t worry if you fail, as you will be given assistance. Then click “Explore Investment Opportunities”. If you fail, a page will appear explaining the investment risks. Read through this and click “Re-take Quiz”.
4. On the next screen put your cursor over “Profile Completeness” on the top right of the screen and select “Verify your Identity”. Complete the information. You will need your National Insurance Number or tax reference and to upload a copy of your passport, driving licence or Identity card as a jpg file and a copy of a recent utility bill as a jpg or pdf file. Then Click “Verify Identity” and “Start Identity Verification”.
5. During this process you will be asked to upload a copy of your identity document (Passport, driving licence or identity card in jpg or png format and a copy of a recent utility bill as a pdf or jpg or png file, so you should scan these documents before you apply.
6. Once your Identity is verified, you will be at the Investment Account page. You can put the equivalent amount of funds into the Seedrs deposit account as your investment (you can do this with a UK debit card only) and click “Confirm Deposit”.
7. Once funds are in your Seedrs deposit account you are in a position to pay for your investment. Alternatively you can pay directly from the campaign page.
8. Click www.seedrs.com/dgm for the Domaine du Grand Mayne campaign. Click the Green “Invest” button. Enter the amount you want to invest (£500 is the minimum to receive full shareholder benefits). Click the box “Make this investment anonymous” if you do NOT wish your name to appear on the Seedrs web site list of investors Choose the payment method you want and click the box by “I have read and agree to the investment agreement” and then click on “Confirm Investment”. You will be sent an email to confirm receipt of your payment.
